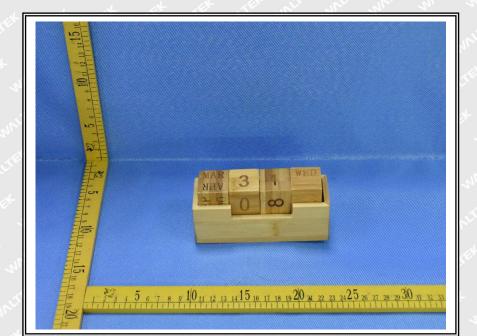

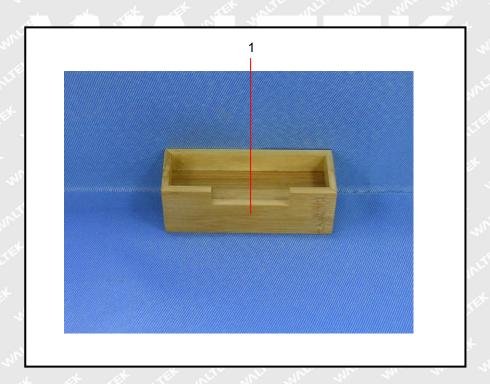
No.1: Beige bamboo base
