










Fig.4 – over view (charging base)






Fig.5 – over view (charging base)




Fig.6 – open view (charging base)






Fig.7 – PCB view (charging base)





Fig.8 - PCB view (charging base)








Fig.9 – battery view (charging base)




Fig.10 – battery view (charging base)






Fig.11 – over view (Earphone)




Fig.13 - open view (Earphone)




Fig.14 – PCB view (Earphone)






Fig.15 – PCB view (Earphone)





Fig.16 – battery view (Earphone)








Fig.17 – battery view (Earphone)
